**Annual Parish
Meeting
8th March**

Parish Council Precept for 2018/19

You will, by now, have received your Council Tax demand from RBWM for 2018/19 and noticed that the precept for the parish has increased by **12.3%**. This increase means that a Band D household will pay an additional **£4.35 per year** – or 36p per month. In total, the precept will raise **£14,757** for the year.

Managing our Assets

However, the parish council has not increased the precept without ensuring it is maximising the income received from its managed assets.

In the year 2018/19, the council will increase this income by **126.6%** (£17,962), building on the increase for 2017/18 of **19.9%** (£2,360). Increased income has, in the main, been generated from rentals for the community room, charging sports clubs for the use of the recreation ground and taking back management of the tennis courts.

The parish council is obliged to correctly maintain all the facilities we provide. To ensure that we can do this, we now put away regular reserves to pay for future repairs or replacement.

For the year 2018/19, these reserve contributions total £20,200, which is more than the total precept increase for the coming year.

Recently, the Jubilee clock was repaired at a cost of close to £2,000. The expansion of the cemetery was financed by a reserve put in place in 2016/17 and the equipment at the recreation ground, paid for by capital funds through S106 developer contributions, is maintained through revenue. Now 5 to 10 years old, it requires more maintenance.

As developer contributions have not been available to us over the last two years, a previous policy of 'replace not repair' can no longer be followed.

Community Infrastructure Levy (CIL)

It is expected that Community Infrastructure Levy funds will be paid to the parish under the agreement with the Royal Borough. As these funds must be spent on 'Infrastructure which supports development', we are keen to hear from you about local infrastructure needs and we will conduct a second residents' survey later this year to gain more input.
